FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR RIVER OAKS AT AQUARINA

THIS FIRST AMENDMENT to Declaration of Covenants, Conditions and Restrictions for RIVER OAKS AT AQUARINA ("First Amendment") is made this 25th day of November, 1996, by AQUARINA DEVELOPMENT, INC., a Florida corporation ("Developer").

WITNESSETH:

WHEREAS, Developer is the developer under the Declaration of Covenants, Conditions and Restrictions for RIVER OAKS AT AQUARINA, recorded on September 25, 1995 in Official Records Book 3507, Page 1670, Public Records of Brevard County, Florida (the "Declaration"); and

WHEREAS, the Developer owns ten (10%) percent or more of the lots in RIVER OAKS and is authorized by Paragraph 14 of the Declaration to amend the Declaration; and

WHEREAS, Developer desires to amend the Declaration.

NOW, THEREFORE, Developer hereby amends the Declaration by this written action as follows:

- Exhibit A to the Declaration, entitled "Architectural Planning Criteria" is hereby amended by revising Subparagraph C by addition of the word "to" and by deleting Subparagraph E of Section 6 as follows:
 - 6. SIGNS. No sign of any kind other than the name and address of the owner shall be displayed to the public view on any lot or improvements except for the following:
 - Homeowners may display one sign per lot not exceeding four (4) square feet, provided said sign is approved in advance and in writing by the ARC.
 - The size, design, and color(s) of all signs shall be subject to approval by the ARC.

C. This provision shall not apply to the Developer.

D. For Sale Signs, not exceeding four (4) square

2. Except as modified hereby, the Declaration shall remain in full force and effect.


