RE: COVID-19 Update 03/16/2020

In the past few days, the news regarding Covid-19 has been evolving quickly. While you might be busy making your own plans, we would like to update you on the steps the we've taken towards community virus avoidance.

The ACSA board met on Friday, March 13, 2020 and established a Covid-19 task force to help determine our next steps. For your safety the following initiatives are effective immediately.

- 1. **Closure and suspended** use of the fitness gym, the community center, and the BC house.
- 2. Bathrooms that serve the tennis, golf and beach (lower level of the BC house) will remain open at this time to help facilitate outdoor physical exercise as recommended by the CDC. However, they are to be used at your own risk and you will need to sanitize touchpoints with your own wipes as cleaning between individuals cannot be guaranteed.
- 3. Those who use the **tennis lockers need to empty them as soon as possible** and to clean them with sanitizing wipes in preparation in the likely future event we need to close this facility entirely.
- 4. We recommend that you do **NOT** use the saunas and showers at the community center and if you chose to do so **it is at your own risk**.
- 5. The HOA administration offices are closed and Pearl and Jeff are working remotely. The admin office phone line is being answered by FirstService Residential Customer Care 24/7. All inquiries received by FSR Customer Care will be assisted. Those inquiries requiring assistance from administration will receive a return call or email as requested during regular office hours.

Additionally, we recommend;

- 1. Use only your own equipment and supplies. No sharing of food and drinks.
- 2. Following CDC recommendations including proper handwashing, not touching your face, and sanitizing your own living space. See flyer below and coronavirus.gov floridahealth.gov
- 3. Maintain social distancing. Meetings or private events that are essential, should be limited to as few people as possible. A distance of 6 feet or greater between people is recommended.
- 4. Alternate plans for the ACSA Annual Meeting are being developed. Once details have been determined a separate communication will be sent to residents.
- 5. Use of virtual social networking is encouraged. Clean your phones and keyboards regularly.
- 6. Each HOA needs to have and maintain a current list of all residents, their contact information and make sure their residents are receiving this and future notices.
- 7. Traveling anywhere at this time even locally is likely to increase your risk. Limiting your travel to what is necessary and self-monitoring for symptoms is something we should all be doing. Call your physician of changes in your condition and call 911 for emergencies.

There is a separate notice that was sent yesterday regarding the changes AGI has taken related to the Brassie Grill, golf, and tennis. Please see the separate email. Please add aquarinacommunitynews@gmail.com to your contacts to ensure you receive AGI / Community updates.

These changes will be continuously re-evaluated to determine when it is safe to return to normal operations. Periodic newsletters will be sent to community residents throughout this period. Your safety and the safety of everyone in our community has been top of mind in making these decisions. Please look out for yourself and those who might need your support during this time. We appreciate and thank you for steps you take to help in this effort.
