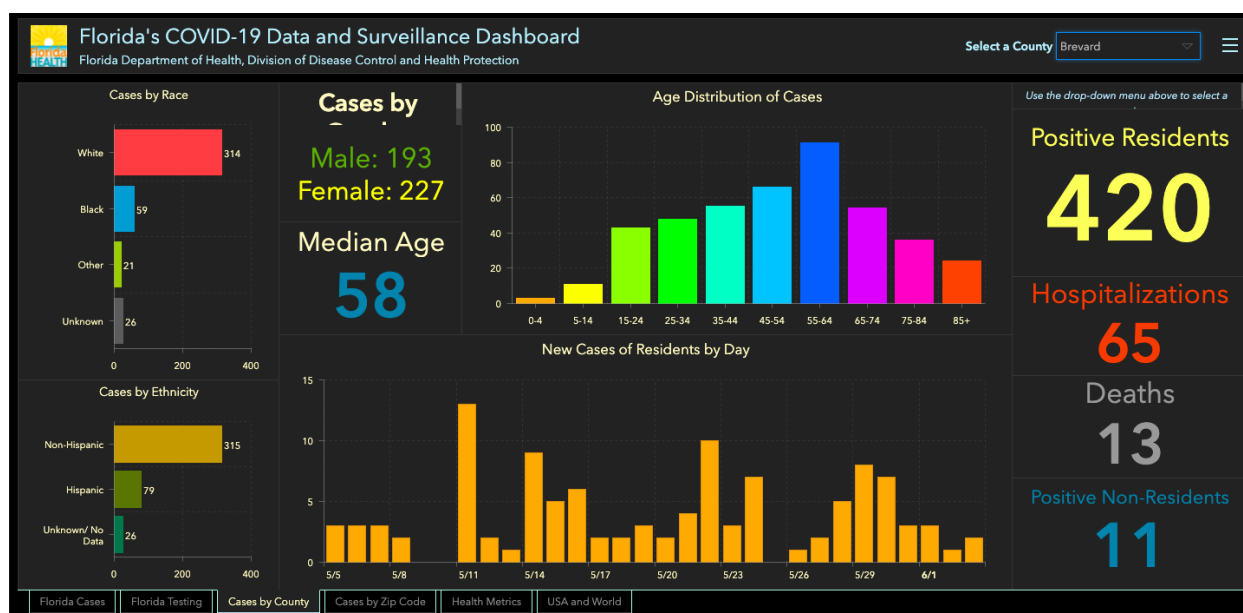
Dear Residents and Neighbors,

Update

The COVID-19 Task Force continues to monitor the coronavirus pandemic in our state, county and local communities to help determine our safest course of action in Aquarina. The purpose of this newsletter is to update you on the current COVID-19 case rate and to announce the opening of our Aquarina gym.

The Brevard County most recent cases from Tuesday, June 2 are:

Brevard County	June 2, 2020	Total
Confirmed cases	2	420
Total COVID19 tests	427	23,404
Percent positive	0.5%	2%
Deaths (actual)	0	13



The COVID19 case rate for our zip code remains low at <5. The total confirmed case rate for Melbourne Beach is 4. For those interested in diving deeper into the data, there is detailed information on the Johns Hopkins [interactive map](#).

For the last several days, Florida has seen a spike in cases with the highest new case rates reported since mid-April. The bigger picture for the country shows a combination of decreasing COVID 19 cases in some areas and increasing in other locations. The CDC (Centers for Disease Control) and NIH (National Institute of Health) both agree that the U.S. is still in the acceleration phase of this novel disease. Aquarina Gym

In accordance with Governor DeSantis' Executive order and plan, https://www.flgov.com/wp-content/uploads/orders/2020/EO_20-139.pdf; <https://www.flgov.com/wp-content/uploads/covid19/5.14.20%20Presentation%20-%20FINAL.pdf> the Aquarina gym at the Administration building is open starting today, Thursday, June 4th with the following guidelines:

1. Users will limit themselves to a maximum of 6 people in the gym at any one time.
2. When the gym is at capacity (6 people), those waiting to enter need to wait outside on the porch of the Admin building until space is available.
3. Users will wipe down the equipment *BEFORE* and *AFTER* each use.
4. Users will bring their own hand sanitizers and wipes to augment the wipes provided in the gym.
5. Users are asked to limit their exercise time to a maximum of 45 minutes whenever it is busy and others are waiting. Please be considerate of each other.
6. The gym has been sectioned into six stations as designated by wall numbers.
7. There is a maximum of one or two people per section, however a **6-foot distance MUST be maintained between users at all times, per Executive Order.**
8. To help users maintain the required safe distance, some equipment is taped off and shall not be used. Do not remove the tape as the spaces are all safely measured.
9. *Users are to self-monitor using these guidelines and use the gym and equipment at their own risk. Security cameras are in place and recording.*
10. All newly reopened facilities in the state are subject to periodic visits from the County Sheriff's office and fines are being levied for noncompliance, so please adhere to these guidelines.

Fully Reopening Aquarina Facilities

The COVID 19 Task Force will be working with the Community Center and Beach Club House committees to develop the necessary guidelines to reopen these facilities soon.

Stay safe, be smart and act responsibly. The risks you take could be critical to your own well-being and the well-being of others.
